The Bylaws direct that “*Additional candidates for the offices to be filled may be placed in nomination by petition signed by at least 2% of the REALTOR® members (109), of which no more than 1% (55) be from the same firm,*” prior to 5 p.m. on Thursday, September 21, 2017. The Bylaws of the **New Orleans Metropolitan Association of REALTORS®, Inc.** direct that no more than three members from each firm may serve at the same time. In addition, in no event shall the number of Category 1 REALTORS® (see Bylaws Article IV, Section 3, a.1.) and REALTORS® who are engaged in the real estate profession in positions of management control on behalf of sole proprietors or corporate officers be less than 50% of the At-Large Directors. The NOMAR Ex-Officio, the CID President, and the GSREIN Ex-Officio do not count in the allotment. Directors whose terms continue into 2018 are:
