The Bylaws direct that “Additional candidates for the offices to be filled may be placed in nomination by petition signed by at least 2% of the REALTOR® members (116), of which no more than 1% (58) be from the same firm,” prior to 5 p.m. on Thursday, September 19, 2019. The Bylaws of the **New Orleans Metropolitan Association of REALTORS® , Inc.** direct that no more than three members from each firm may serve at the same time. In addition, in no event shall the number of Category 1 REALTORS® (see Bylaws Article IV, Section 3, a.1.) and REALTORS® who are engaged in the real estate profession in positions of management control on behalf of sole proprietors or corporate officers be less than 50% of the At-Large Directors. The NOMAR Ex-Officio, the CID President, and the GSREIN Ex-Officio do not count in the allotment. Directors whose terms continue into 2020 are:
