Enclosed with this letter is your 2018 NOMAR dues billing, including an invoice for each sales person associated with your company. Dues are payable now, and become delinquent on December 1, 2017. The following delinquent fees apply: Dec. 1st = \$50, Jan 1st = \$75, Feb 1st = \$100. If you choose to send a license(s) back to LREC, or if an agent is no longer with you or is going inactive, please advise us in writing. We cannot terminate membership, nor refund NOMAR or GSREIN Dues without written notification. In order to refund NOMAR dues, a refund request in writing must be received no later than December 29th. NOMAR dues refunds cannot be issued after this date. In order to refund GSREIN dues, a refund request in writing must be received no later than January 14th, 2018. GSREIN refunds are only issued on January 14th and cannot be issued after this date. A \$25 processing fee will be deducted from all refunds. If you did not receive an invoice for an agent associated with your firm, it is your responsibility to notify us immediately as you are responsible for dues for all licenses that you hold. If you have new licensees affiliated with your firm, call us and we will assist the agent in establishing services. **Please be reminded that you are responsible for dues for ALL LICENSES that you hold.**

Also, we would appreciate you making any corrections or additions to the information contained on your billing statement, such as address changes, the addition of an e-mail address, etc. The agent's home address is printed on the statement only if it has been provided to NOMAR.

Your local dues sustain the products, services and operations of NOMAR at both the Northshore and Southshore facilities. The local dues assessment for NOMAR will remain the same for 2018.

You will note on the statement a voluntary contribution to LARPAC.
